We will endeavor to meet all the deadlines set, but we can't be responsible for a missed launch date or a deadline if you have been late in supplying materials or have not approved on time at any stage.

We will also maintain the confidentiality of any information that you provide.

If it is deemed to be an issue that is due to any aspect of our hosting service, it will be rectified as soon as possible. We understand that things can go wrong, so understanding your backup requirements and managing the process is vital to your peace of mind. We are able to offer you daily backups (that are kept for 7 days) that as standard for all our clients.

Payments

As a business we know you will appreciate the importance of being paid on time and we have the same need and expectation. We therefore expect that you will honour the payment schedule. Any delay in payment may lead to a loss of your website. You agree to stick tight to the following payment schedule, which will be as follows, but may be revised based on further conversations between us.

Renewal and Payment

Our hosting is renewed annually. The invoice for your hosting will be sent one month prior to the renewal date. If the invoice is not paid in full by the due date (unless notified) then the service will not be renewed, this may result in loss of website data.

If you wish to terminate your hosting at any point, we will require 30 days before termination. Hosting will be invoiced for up to the date of termination. There is a hosting transfer costs and the full balance of all outstanding invoices must be paid before your domain will be released to you.

You guarantee to us that any elements of text, graphics, photos, designs, trademarks, or other artwork that you provide with your web site files are either owned by your good selves, or that you have permission to use them.
